REER S.p.a., the owner of the processing of personal data of visitors to the website, pays special attention to their protection, the guarantee of their confidentiality and their protection from any action that may represent a violation.

But what are cookies? "Cookies" in English are small text files necessary for the server of the website that installed them to obtain information about the specific activity the user performs on the pages that make up the site (language choice, map display, etc.).

Cookies can be temporary (session cookies) and delete themselves at the end of the session or (permanent cookies) remain saved in the device's folders for long periods, reactivating each time the user reconnects to the same remote server.

Permanent cookies may also contain a unique identifier code to enable tracking of web page interactions and create a personalized user profile based on statistics and, for example, search habits. Through the information collected by such cookies, specific advertisements can be presented to the user and such as to meet their interests. These cookies can be activated with the user's consent.

Type of data processed by the Site

Some personal identifying data (first and last name, country and email address) are voluntarily released by the user and are necessary for his registration and to allow him to access the restricted areas of the site (e.g. Download Area commercial documentation, manuals and software, Academy Area, Technical Support Area, Contact Area). Other data (e.g. IP address of the device from which browsing is done, operating system settings, software version, browser, language, etc.) are collected in an automated way by cookies. The data collected by technical cookies are, in addition, stored to the extent strictly necessary to ensure the security, confidentiality and integrity of the information being communicated between the devices and the server hosting the site.

Managing cookie preferences

Purpose of data collection. Data collected through automated cookie functions are used, in aggregate form, solely for the proper functioning of the site and to ensure a positive user experience. No information offered by cookies is related to a specific user and therefore it is not possible to identify them in any way. Cookies also act, through the information collected, to ensure the security of the site from breach attempts, attacks, intrusions and, consequently, of the user who is browsing. Among the data recorded in automatic mode is the IP address of the device that is browsing. This information could, in accordance with current laws, be used to block attempts to intrude and violate the site, which may constitute a crime. The site owner never uses such data for indirect identification of the User.

The collection of data is done automatically through technical cookies whose function is essential for the proper functioning of the site. The deselection and blocking of such cookies by the User does not allow the complete and proper functioning of the site.

On the other hand, "analytics" and "marketing" cookies are used subject to the user's consent, which is always given through the voluntary and autonomous setting of cookies.
